Partney church of England Primary School Coronavirus (COVID-19) catch-up premium

The government COVID-19 catch-up premium has been established to mitigate the effects of the unique disruption caused by coronavirus. The grant will only be available for the 2020-2021 academic year.

Schools should use this funding for specific activities to support pupils to catch up for lost teaching time over the previous months. To support schools to make the best use of the funding, the EEF has published a support guide:

As with all government funding, school leaders and governors must be able to account for how the money is being used. Therefore the impact and spending strategy for this catch-up premium will be reviewed at Governors meetings throughout the 2020-2021 academic year. When Ofsted recommence routine inspections, they will make judgements about the quality of education being provided which will include how you are using the funding to ensure the curriculum has a positive impact on all pupils.

Context:

As a small school, our Catch – up allocation is also quite small. We have concentrated on using the money for additional TA employment, one in KS1 and the other in KS2, so that the time and resource can be spent on key areas: phonics teaching for reading (KS2 ready); and support for reading and maths in Class 3 - getting our pupils 'secondary ready'. In the plan I have also included other items that are over and above what we would normally do as a school, so our spending can be seen in a wider context, although not necessarily coming from the same 'Catch – up' source.
